ROCK RIVER INSURANCE COMPANY, BULAU 219

ALWIN E. BULAU'S Footprints of Assurance attributes number 219 to the Rock River Mutual Fire [underlining added for emphasis] Insurance Company, Rockford, Illinois, 1852-1869.

I have a business card in my collection for F. Babcock, Traveling Agent for the "Rock River Insurance Company, of Rockford, Illinois." The card states that insurance is written, "Upon either the Mutual or Stock plan, as the applicant may elect." I then Googled both "Rock River Insurance" and "Rockford" and had three hits. The first was an 1869 letter with the letterhead of the Rock River Insurance Company, West Rockford, Illinois. The letterhead lists a capital of \$500,000 and a charter date of 1852. The beginning date agrees with Bulau. The second hit was an "1860 Fort Madison City [lowa] Directory" listing the "Rock River Insurance Co., of Rockford, Ill., F.S. Shigley, agent, cor Johnson & Arch." The third was a postal cover with a picture of the company's office in Rockford, Illinois. It was posted to Winona, Wisconsin and the year was not legible.

I then Googled "Rock River Mutual Insurance" and had only one hit. It was from the *Wisconsin Express*, Thursday, February 27, 1851 and referred to the reading of a bill in the state legislature to organize a Rock River Mutual Insurance Company. Another source, the 1901 Wisconsin Insurance Report lists under "Mutual Fire Insurance Companies of Wisconsin" a "Rock River Insurance Company, Beloit, Wis. [organized] Nov. 9, 1860." The report also states that the company failed in 1869. The 1869 date is the same termination date of Rockford's Rock River Insurance Company. I am unable to verify the cessation date for the Rockford insurer.

Based on the above, I conclude that the correct name for Bulau 219, whose two marks were found in Illinois, should be the "Rock River Insurance Company." Please note your *Footprints* and *Addendum* page to reflect this change.

Perhaps some of our Illinois FMCA members can verify the cessation date of the company.

NOTES ON THE UPCOMING 2007 FMCA CONVENTION

"If I should ask, "What is the worst thing that can come to our city?" you might reply: "An epidemic, carrying off our sons and daughters and making homes desolate," or even worse, "a hostile, plundering, destructive army." But worse than these, I say, is the invasion of our city by a body of men who come to revel and carouse in illegitimate ways, bringing a curse and leaving a stain that cannot be washed out." They bring shame, discredit and disgrace. It is true, as some point out, that this gives the city an advertisement and commercially are beneficial, but gain from such a source is loss and disgrace."

These words were spoken by the Reverend R. D. Naylor, pastor of the Linden Street Methodist Episcopal Church, in a sermon denouncing the 1903 Pennsylvania State Firemen's Convention coming to Allentown.

I only refer you to these words in the hope that the attendees of the upcoming 2007 Louisville, Kentucky, FMCA convention will bear in mind the delicate nature of the citizens of Louisville. The Pennsylvania State Firemen's Association had, as a centerpiece, their "Asphalt Dance." I trust that the FMCA's auction and banquet will not draw such notoriety. Since, "Gambling devices are not tolerated and the disgusting side shows are not allowed," there should be none of the usual problems at this convention.

"FIRE MARK PHILADELPHIA 1817 INSURANCE RARE, PLUG PLATE"

The above heading and following was for an item recently offered on eBay.

VERY RARE BECAUSE THIS IS NOT A HOUSE MARKER

THIS IN AN ACTUAL FIRE PLUG

(FIRE HYDRANT) MARKER

THEY USED TO CALL THEM FIRE PLUGS.

WHAT I FIND EXTREMELY COOL ABOUT THIS PIECE OF HISTORY, IS THAT THIS WAS AN ASSOCIATION MARK THAT THEY WOULD PLACE ON THEIR HOMES TO LET THE FIRE FIGHTERS KNOW THAT ARE A MEMBER.... AND IF YOU DIDN'T HAVE ONE... OH WELL LET IT BURN.

FIRE ASSOCIATION MARK DATED 1817.

FLAT AND MADE OF IRON, WITH A FULL STREAM OF WATER GUSHING FROM A HOLE ATTACHED TO OLD TIME FIRE PLUG

THE LETTERS F A WERE GILDED, AS WERE THE PLUG AND HOSE. THE GRASS AT THE BASS (SIC) OF THE HYDRANT WAS GREEN

THIS IS THE BEST PIECE ON EBAY MINIMUM VALUE OVER \$600. MUSEUM QUALITY PIECE

THIS CAME FROM AN ESTATE OF A VERY OLD MAN THAT WAS IN THE INSURANCE BUSINESS AND IT WAS HANDED DOWN TO HIM.

"HOUSE PLATES"

"House Plates – A very heavy demand for Phoenix house-plates rendered it necessary that a second supply be ordered from our manufacturer, the first having been entirely exhausted; and having just received them, we are prepared to furnish all agencies which heretofore have not been supplied. Let house-plates be placed on every risk you take."

July 1, 1866. From a book entitled Facts and Figures, which is a bound volume of newsletters that were "Designed for the use and reference of Agents of the Phoenix Insurance Company, Hartford, CT."
